Description

Course Description: This course provides students opportunities for analysis, synthesis, and application of critical thinking applied to decision making at all levels in an organization. This course equips students with critical thinking skills to identify problems utilizing rational decision making. Students learn to solve organizational problems and provide strategic direction based on critical thinking.

Course Scope:

Students taking this course will examine the decision making process, from problem formulation and identification to argument construction and support. The emphasis is on understanding the rudiments of a compelling idea that is communicated in a credible and persuasive manner. Critical thinking is central to the rational decision making that is common in business and in everyday life, and is the key to identifying beneficial choices and creating persuasive proposals. Students will focus on examining arguments, researching positions, and writing convincing articles.

Objectives

This course of instruction is intended to provide the student with a solid academic background to continue taking business courses, and for those students so inclined, the background needed to start, run, and grow successful ventures. Students will:
