Course Description: This course will provide an introduction to the collection, preservation, and basic crime scene investigations. Furthermore this course will also focus on the laws and court decisions relating to the admissibility of evidence as well as the appropriate methods of interrogation and its uses in the criminal justice process.

Course Scope:

This course is divided into 8 weeks and is organized to give students a broad context in which it will provide you with the information and processes needed to identify, collect process and have evidence admitted at trial. The techniques procedures and resources presented are applicable whether the evidence being collected is related to a homicide or a forgery, and can be expanded or adapted to the investigation of any incident -- criminal or civil. The learning process is totally dependent on your close reading of the course material, outside resources, additional research, successful completion of the course assignments, and your participation and interaction with the course professor and students. There many individual readings, each discussing in detail most of the techniques and procedures that must be followed for evidence to be used in a proceeding to discern the truth. The Forums will be utilized to explore course topics in detail allowing students to share prior education, experience, and knowledge of the practical and legal procedures related to evidence.
