Course Description: This course focuses on the essential framework and first steps towards the student's objective of an entrepreneurial opportunity. The first portion of the course focuses on a framework for your business plan. The remainder course topics center on business plan elements, such as competition, marketing, operations, and other issues essential to the delivery of a business plan. In this course, the student begins the process of writing a business plan, which will be used and updated throughout the program. (Prerequisite: ENTR150 and ENTR215 and ENTR300)

Course Scope:

There are thousands of people who have the dream of opening their own business. Most first-time entrepreneurs start out with a little more than an idea. By combining talent with practicality, you can take your idea and form it into a functional business plan. The goal of this course is to teach you how to do just that.

The course text supplies the steps and you supply the effort. Because laws and tax issues are constantly in flux, consult your legal counsel and advisors rather than relying on the material in your text or in this course. All of the forms in the texts are provided as examples, and should not be used without benefit of counsel.
