Description

Course Description: This course is a study of the environmental organization at the federal level, to include duties and responsibilities of federal environmentally-focused agencies, non-environmental agencies and organizations that have environmental impact or related responsibilities, and other federal administrative issues focused on environmental bureaucracy, contracting, and/or outsourcing to private organizations.

Course Scope:

This course will explore the structure, mandates and programs of U.S. Federal departments and agencies involved in environmental activities. The student will learn these fundamentals, including relevant terminology, case studies, and will investigate current events in Federal environmental organization and activities. The student will be challenged to evaluate programs and philosophies at the end of the course. Assignments include short papers and an online final exam.
