#### Research Paper Assignment

Students are required to complete one (1) eight (8) page research paper on a health care topic of their choice. Students must submit their research topic for approval in the second week of the course through the Assignment Area of the classroom. Students are required to submit an outline of the research paper in Week 4. Papers must be a minimum of eight (8) double spaced pages, not including the cover page and reference pages (or abstract and table of contents which are not required - but if used). Charts, graphs, photos, drawings, lists and extended quotes will not count against the eight (8) pages of written text required. The APA standard will be used. A minimum of seven (7) bibliographic sources must be used and cited for the research paper.

The students will be expected to provide comprehensive, relevant and well supported points in all the written works. The students are advised to proofread for grammar and spelling as well as for flow and organization of all written works. All submitted work should adhere to a font and page set-up that is readable and neat. The students are expected to follow APA formats. Assignments completed in a narrative essay or composition format must follow APA guidelines. This course will require students to use the citation and reference style established by the American Psychological Association (APA), in which case students should follow the guidelines set forth in *Publication Manual of the American Psychological Association* (6<sup>th</sup> ed.). (2001). Washington, D.C.: American Psychological Association.

All written submissions should be submitted in a font and page set-up that is readable and neat. Students should adhere to a consistent format, which is described below.

- Typewritten in double-spaced format with a readable style and font and submitted inside the electronic classroom (unless classroom access is not possible and other arrangements have been approved by the professor).
- Times New Roman or Arial 12-point font.
- Page margins Top, Bottom, Left Side and Right Side = 1 inch, with reasonable accommodation being made for special situations and online submission variances.
- Correct grammar, spelling, and sentence structure are expected for your lessons, posts, and responses to other students. I also expect you to use proper formatting for your references and references are expected (APA format).
- Automatic point deductions for typographical, spelling and grammatical errors.

### **Citation and Reference Style**

# **Online Library**

### Turnitin.com

**Turnitin.com** is a web-based <u>plagiarism</u> prevention application licensed, for campus use, through the APUS Online Library. The quick submit option lets faculty upload and check suspicious papers, without requiring student to create their own Turnitin.com profiles.

Turnitin.com analyzes electronic submissions of student writing, compares them to the contents of a huge online database, and generates a customized Originality Report. The database used to produce this analysis contains a massive collection of documents available on the Internet from both free and commercial sources, as well as the full texts of all other papers that have been previously submitted to Turnitin.com.

Similarity index is based on the amount of matching text to a submitted paper:

Blue = no matching text

Green = one word to 24% matching

Yellow = 25 -49% matching text

Orange = 50-74% matching text

Red = 75-100% matching text

Turnitin is integrated into the Assignments tool in all online classrooms so there is no need to log in to turnitin.com and/or enter a specific course code. Within 15 minutes of submission, your originality report should be available. You can access the report by selecting the assignment. Next to your attached file will be a bar, accompanied by a percentage (your paper's similarity index). Click this bar to view your originality report. If you have questions about how to interpret your report, click here.



It is every student's responsibility to review the Originality Report. Recurring high match rates on students' assignments may result on point

deduction, a zero in the assignment, and other severe consequences based on the student handbook contents regarding plagiarism.
