Course Description:

This course provides a theoretical framework for the understanding of the ethical, sociological, organizational, political, and legal components of community risk reduction, and a methodology for the development of a comprehensive community risk reduction plan.

Course Scope:

This course addresses the theory and process of community risk reduction activities within the fire service. In order to effectively reduce the effects of fire and other injuries in the communities served, fire departments must systematically implement risk reduction activities. Partnering with community groups in order to reach the most vulnerable segments of the population is emphasized. Students will study and discuss the roles and responsibilities of community risk reduction from the upper levels of fire administration down to the company and station level. The final paper requires the student to develop a community risk reduction plan, which encompasses the knowledge they have acquired during the course.
