Course Description (Catalog)

This course focuses on the principles, practices, and processes of dispute and conflict resolution. The course draws on interdisciplinary materials from social science, decision theory, management/labor relations, law, and others. Course curriculum incorporates a review of nonbinding dispute resolution strategies such as negotiation and mediation, binding strategies including arbitration, and psychological challenges to overcoming conflict such as cognitive perception biases.

Course Scope

This course introduces the important conflict management mechanisms of alternative dispute resolution (ADR) as well as effective methods of negotiation.
